Mid-Atlantic Association of Community Health Centers, in support of National Health Center Week 2010, is offering mini-grants to FQHCs in Maryland and Delaware. The second week of August each year is dedicated to recognizing the service and contributions of Community, Migrant, Homeless and Public Housing Health Centers in providing access to affordable, high quality, cost-effective health care to medically vulnerable and underserved people in the U.S. This year's commemoration is special because 2010 also marks the 45th Anniversary of the creation of the Health Centers Program. MACHC is offering \$250 per health center system in celebration and support of National Health Center Week.

These mini-grants are for supporting your health center's planned activities for National Health Center Week. This may include, but are not limited to; health fairs, immunization events, outreach efforts, run/walk events, and open houses. **Funds cannot be used for food, beverages or prize/give-away items.** In addition to the \$250 mini-grants, FQHCs in Maryland will receive H1N1 Promotional Materials and Give-Aways in support of promoting H1N1 vaccinations.

All FQHCs in Maryland and Delaware that are members of MACHC are eligible to apply for the MACHC mini-grant. In receiving these grants, your organization agrees to allow MACHC to share your event details and information to the public at large and to other organizations through (but not limited to) our websites, E-Digest, press releases and other outreach conducted for National Health Center Week.
